## By The Numbers: How Medicaid Strengthens Delaware

Medicaid is not only a lifeline for millions of Delawareans, it strengthens our communities in countless ways. These are reasons why the program is overwhelmingly popular: [74 percent](#) of Americans support Medicaid.

### DELAWAREANS DEPEND ON MEDICAID

- **247,948 Delawareans Are Covered Through Medicaid.** 247,948 Delawareans [have medical coverage](#) through Medicaid - most of them children, seniors, and people with disabilities.
- **In Delaware, Adults Up To 138 Percent Of The Federal Poverty Line May Enroll In Medicaid.** After expanding Medicaid, Delaware residents earning up to 138 percent [of the federal poverty line](#) are now eligible to enroll in Medicaid.
- **67,900 Delawareans Have Gained Coverage Through Medicaid Expansion.** Thanks to Medicaid expansion, 67,900 Delaware residents [are enrolled](#) in the program.

### MEDICAID IS A LIFELINE FOR CHILDREN, SENIORS, AND PEOPLE WITH DISABILITIES

**43 Percent of Delaware's Children Rely on Medicaid.** 43 percent of Delaware [children rely](#) on Medicaid for coverage. Medicaid pays almost \$4 billion annually in school-based health services. Schools depend on these funds connect students with vital health resources — [68 percent](#) of school superintendents said that they used these funds to keep nurses, counselors, and speech therapists on staff.

**Medicaid Supports 80 Percent Of Delawareans In Nursing Homes.** 80 percent of Delawareans living in nursing homes [have coverage](#) through Medicaid.

**Medicaid Covers 17 Percent of Delaware's Seniors and People with Disabilities.** In Delaware, 17 percent of seniors and people with disabilities [have health coverage through Medicaid](#), including for nursing home care. Nationally, approximately [one in four people](#) on Medicaid are seniors (9 percent) or people with disabilities (15 percent). However, their care represents about [two-thirds](#) of all Medicaid spending. In other words, funding cuts to Medicaid will disproportionately affect the most vulnerable.

### MEDICAID HELPS DELAWAREANS ACCESS TREATMENT FOR OPIOID ADDICTION

**Medicaid Covers [One In Four](#) Americans With An Opioid Use Disorder.** Medicaid pays for 40 percent of Delaware's [buprenorphine](#) expenditure, a medication used to treat opioid addiction.

### REPUBLICANS' WAR ON THE ACA AND MEDICAID JEOPARDIZES COVERAGE FOR NEARLY 250,000 DELAWAREANS

**67,900 Delawareans Enrolled Through Medicaid Expansion Now At Risk.** The Graham-Cassidy bill would eliminate [Medicaid expansion](#), which has helped 67,900 Delawareans receive quality, affordable coverage, and put part of its funding into inadequate block grants. The bill would further punish states that expanded Medicaid by [redistributing](#) funds to states that did not expand Medicaid.

**247,948 Delawareans With Traditional Medicaid Coverage, Including Seniors, People With Disabilities, And Children, Are At Risk.** The Graham-Cassidy bill that President Trump revived in his FY19 budget proposal would turn traditional Medicaid into a per capita cap, meaning the 247,948 Delawareans who are [enrolled](#) on Medicaid would have their care jeopardized. Medicaid disproportionately helps children, seniors in nursing home care and people with disabilities. A study by [Avalere](#) found that Graham-Cassidy would cut funding for people with disabilities by 15 percent and 31 percent for children by 2036.

**105,766 Delaware Children's Care Is At Risk.** 105,766 Delaware kids are currently [enrolled](#) in Medicaid and CHIP, and their care could be at risk because of funding cuts in Graham-Cassidy.
