By The Numbers: How Medicaid Strengthens New Mexico

Medicaid is not only a lifeline for millions of New Mexicans, it strengthens our communities in countless ways. These are reasons why the program is overwhelmingly popular: <u>74 percent</u> of Americans support Medicaid.

NEW MEXICANS DEPEND ON MEDICAID

- **743,780 New Mexicans Are Covered Through Medicaid.** 743,780 New Mexicans <u>have medical coverage</u> through Medicaid most of them children, seniors, and people with disabilities.
- In New Mexico, Adults Up To 138 Percent Of The Federal Poverty Line May Enroll In Medicaid. After expanding Medicaid, New Mexico residents earning up to 138 percent of the federal poverty line are now eligible to enroll in Medicaid.
- **253,400 New Mexicans Have Gained Coverage Through Medicaid Expansion.** Thanks to Medicaid expansion, 253,400 New Mexico residents <u>are enrolled</u> in the program.

MEDICAID IS A LIFELINE FOR CHILDREN, SENIORS, AND PEOPLE WITH DISABILITIES

53 Percent of New Mexico's Children Rely on Medicaid. 53 percent of New Mexico <u>children rely</u> on Medicaid for coverage. Medicaid pays almost \$4 billion annually in school-based health services. Schools depend on these funds connect students with vital health resources — <u>68 percent</u> of school superintendents said that they used these funds to keep nurses, counselors, and speech therapists on staff.

Medicaid Supports 66 Percent Of New Mexicans In Nursing Homes. 66 percent of New Mexicans living in nursing homes <u>have coverage</u> through Medicaid.

Medicaid Covers 19 Percent of New Mexico's Seniors and People with Disabilities. In New Mexico, 19 percent of seniors and people with disabilities <u>have health coverage through Medicaid</u>, including for nursing home care. Nationally, approximately <u>one in four people</u> on Medicaid are seniors (9 percent) or people with disabilities (15 percent). However, their care represents about <u>two-thirds</u> of all Medicaid spending. In other words, funding cuts to Medicaid will disproportionately affect the most vulnerable.

MEDICAID HELPS NEW MEXICANS ACCESS TREATMENT FOR OPIOID ADDICTION

Medicaid Covers <u>One In Four</u> **Americans With An Opioid Use Disorder**. Medicaid pays for 30 percent of New Mexico's <u>buprenorphine</u> expenditure, a medication used to treat opioid addiction.

REPUBLICANS' WAR ON THE ACA AND MEDICAID JEOPARDIZES COVERAGE FOR MORE THAN 740,000 NEW MEXICANS

253,400 New Mexicans Enrolled Through Medicaid Expansion Now At Risk. The Graham-Cassidy bill would eliminate <u>Medicaid expansion</u>, which has helped 253,400 New Mexicans receive quality, affordable coverage, and put part of its funding into inadequate block grants. The bill would further punish states that expanded Medicaid by <u>redistributing</u> funds to states that did not expand Medicaid.

743,780 New Mexicans With Traditional Medicaid Coverage, Including Seniors, People With Disabilities, And Children, Are At Risk. The Graham-Cassidy bill that President Trump revived in his FY19 budget proposal would turn traditional Medicaid into a per capita cap, meaning the 743,780 New Mexicans who are <u>enrolled</u> on Medicaid would have their care jeopardized. Medicaid disproportionately helps children, seniors in nursing home care and people with disabilities. A study by <u>Avalere</u> found that Graham-Cassidy would cut funding for people with disabilities by 15 percent and 31 percent for children by 2036.

343,408 New Mexico Children's Care Is At Risk. 343,408 New Mexico kids are currently <u>enrolled</u> in Medicaid and CHIP, and their care could be at risk because of funding cuts in Graham-Cassidy.
