

Driving Down Health Care Costs for Georgians

Last year, President Biden and Democrats in Congress passed the Inflation Reduction Act, which drives down health care costs for families across Georgia. Between lowering premium costs by [\\$1,487](#) on average, capping insulin costs, and stopping drug companies' egregious price hikes, the new legislation is already working for the Georgians. Soon, seniors' drug costs will be capped at \$2,000 annually, and Medicare will finally be able to [negotiate lower drug prices](#) — no thanks to Republican lawmakers who unanimously voted to maintain the status quo and keep health care costs high.

This summer, the Biden administration is implementing the Inflation Reduction Act and also taking action to eliminate [surprise medical bills](#) and [limit junk insurance](#) plans that do not need to cover people with pre-existing conditions like asthma, cancer, and diabetes.

Minority Leader Rep. James Beverly Is Standing Up For Georgians' Care

Georgia's Congressional Republicans Are Fighting to Raise Costs on Georgians' Health Care

Georgia's Congressional Republicans voted to make over [49 million](#) Medicare Part D beneficiaries pay more for health care costs by preventing Medicare price negotiation power. Every Republican in Congress also voted against capping insulin copays for Medicare beneficiaries at [\\$35](#) a month starting [this year](#). On top of this, Republicans worked [behind the scenes](#) to make sure that the \$35 insulin cap would not apply to all Americans. Led by Republican Scott Perry, with no public dissenters, the Republican Party went on a [warpath](#), threatening to shut down the government, potentially [costing Americans billions](#), in order to make sure health care costs remained unsustainably high for Americans.
