A fierce defender of affordable health care access, Representative McClellan has been on the front lines of the Republican war on health care. During her tenure in the Virginia House of Delegates, Rep. McClellan <u>created</u> the Virginia Health Benefits Exchange under the Affordable Care Act, which will provide more affordable health insurance for approximately 300,000 Virginians and led the fight to successfully expand Medicaid coverage to over 400,000 Virginians. In just her first year in the House of Representatives, Rep. McClellan has <u>cosponsored</u> more than 30 pieces of legislation to expand access to health care while reducing costs.
